At Bridgelea Primary School, we expect children to attend and be on time at school every day, as long as they are fit and healthy to do so.

Why is attendance so important?

- Regular school attendance is an important part of giving children the best possible start in life
- Poor attendance can affect children's ability to make and keep friendships; it is a vital part of growing up.
- Setting good attendance patterns from an early age, through primary school will also help your child later on in their life

Why is being on time so important?

- Gets your day off to a good start and puts you in a positive frame of mind
- Sets positive patterns for the future
- Leads to understanding that school is important and education is valuable
- Being late to school can have a big impact over the whole school year

When can an absence be authorised?

- Illness/Infectious illness
- Urgent medical or dental appointments
- Day of religious observance
- Exceptional special circumstances (Head Teachers discretion)
- Holidays which have been authorised by the Head Teacher
- When attendance is not a concern.

When can an absence be unauthorised?

- When no reason is provided
- Minor illnesses
- Being tired
- Birthdays
- Shopping trips
- Holidays where permission has not been sought or when a child leaves earlier or returns later than agreed
- If your child's is identified as their attendance as being a cause for concern
- Sibling not in school
- Thinking it is an inset day

When your child is too ill to attend school?

How can you do to help?

- Talk to your child about school

What the law says ...

As a parent, ensuring your child's regular attendance at school is **your legal responsibility** and permitting absence from school without good reason is an offence and may result in a fixed penalty notice; this could lead to prosecution and a fine of up to £1000

What the government says ...

Attendance figures of 90% and below are classed as 'persistent absentees'. In order for your child to reach their full potential, they must attend school for a minimum of 95% a year
